- *10% of PayPal receipts*

- *Bank reconciliations and Budget items review.*

Our findings were as follows:

No material loss of financial assets exists and the Chapter has satisfactory internal controls.

A case of Bank fraud occurred resulting in the chapter's operating account being closed and a new account opened. However, no financial loss was sustained by the chapter.
