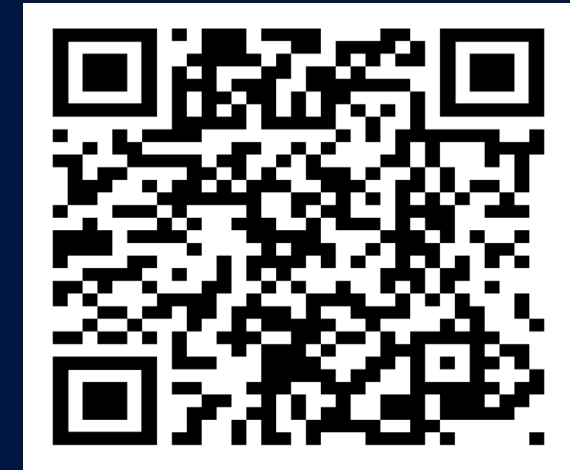

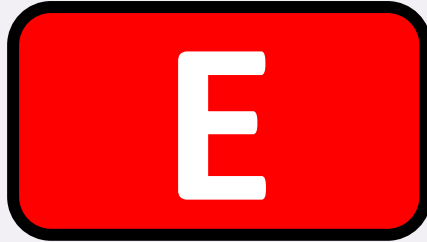

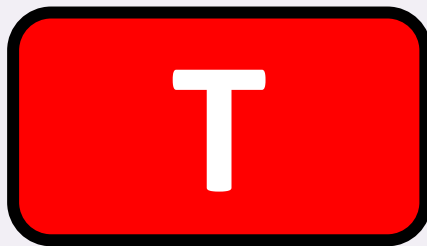

Establish and be familiar with your Emergency Plan for home, work, and all Delta meetings---surroundings, exits, situational awareness, evacuation locations, emergency supplies



Keep your Red Envelope with you at all times. Make sure that information on the form is complete. REMEMBER to include personal contact of who should be notified in an emergency



- **Talk** to your accountability partner (“sister keeper”)
- **Ticket** (form) include your ‘soror on site’ information on back of registration badges and use buddy system for events
- **Tell** someone of your planned activities. If you see something, say something

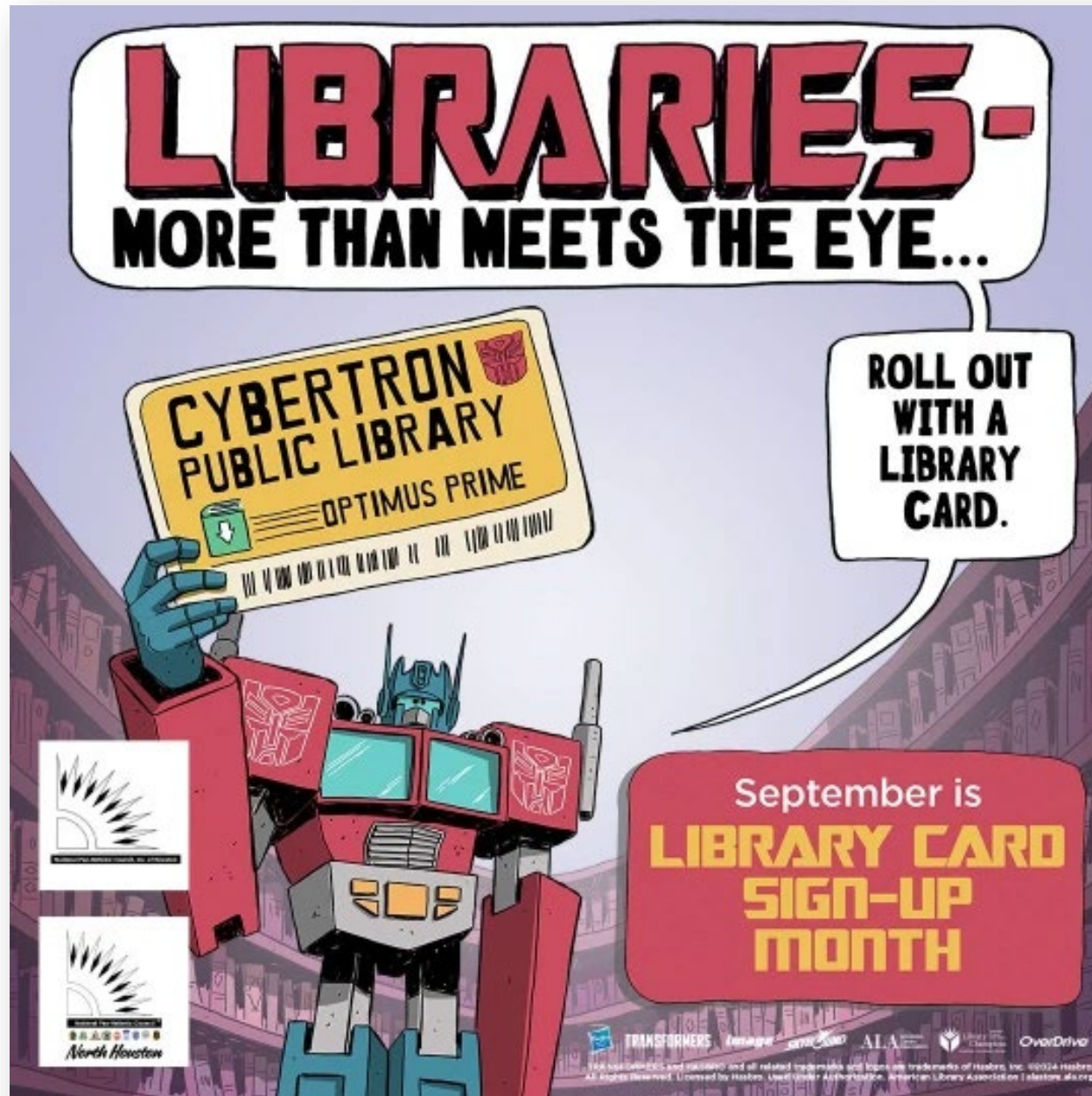
